The Compact Advocacy Programme, based at NCVO, helps mediate and support better outcomes for voluntary and community groups in their dealings with public bodies. We provide advice on Compact principles, and free advocacy where Compact commitments have not been met. We are part of the Empowering the Voluntary Sector project, and work closely with lawyers specialising in public law.

- Consultation deadlines extended to 12 weeks
- Longer term funding secured
- Improved partnership working with local public bodies, including recognition of the importance of independence for voluntary organisations
